Directions to: Rabun Arena. 100 East Boggs Mountain Rd. Tiger, Georgia 30576

Directions from Atlanta: Take I-85 North, keep left at the fork and take I-985 North, I-985 will end and change to GA-365N/US-23N. Follow North for 29 miles and keep left to GA-15 N/US-23 N/US-441 N. Go north for 18.5 miles and follow signs for Clayton. Turn right onto Boggs Mountain Rd, stay right at fork onto Longview, entrance to arena (trailer entrance) will be on your left. Watch for signs.

From Greenville Spartanburg Take I-85 South to exit 19B for US-76W/S Carolina 28 W toward Clemson. Follow US-76W for approximately 55 miles to Clayton, GA. Turn left onto US-441 for 4.5 miles. Left onto Boggs Mountain Rd, stay right at fork onto Longview, trailer entrance to arena will be on your left.

From Asheville, NC: Take I-40 West to exit 27 for US-74 toward US-19/US-23/Clyde/Waynesville/Maggie Valley/Franklin/Murphy/Atlanta. Continue onto US-74 W/Great Smoky Mountains Exp for 26 miles. Take the US-23 S ramp to US-441 S/Dillsboro/Franklin/Atlanta/US-64 W and Continue onto US-23 S for 20.5 miles. Take the ramp onto US-23 S/US-441 S and continue for 26 miles. Travel through Clayton, the arena will be approximately 3 miles South of town on the left. Turn left onto Boggs Mountain Rd, stay right at fork onto Longview, entrance to arena (trailer entrance) will be on your left. Watch for signs

From Chattanooga, TN: Take I-24 East. Take exit 185B on the left to merge onto I-75 N toward Knoxville for 19.3 miles. Take exit 20 toward US-64 E/Cleveland. Merge onto US-74 E (signs for Cleveland/US-64 E/US-11/Cherokee/National Forest/Ocean River) for 6.5 miles. Merge onto TN-40 E/US-64 E/US-74 E via the ramp to Ocoee and go 57.7 miles. Turn right onto US-64 E for 13.5 miles. Turn right onto NC-69 S for 3.5 miles. Continue onto GA-515 W for 1.1 miles. GA-515 W turns left and becomes GA-2 E/US-76 E for 31.2 miles. Turn right onto US-441. Travel approximately 4.5 miles South from when you turn onto US-441S. Turn left onto Boggs Mountain Rd, stay right at fork onto Longview, entrance to arena will be on your left (trailer entrance). Watch for signs

- Please be responsible and pick up after your terriers and yourselves. NO SHAVINGS or grooming in the main arena.
- No Post Entries for racing unless to fill heats.
- Post Entries for other divisions will be accepted at the Registration Booth
- Move ups in G-T-G, after the Registration Booth closes, will be taken by the G-T-G Steward for the pre-entry price. No move ups to Championship Go-to-Ground classes, except Puppy.
- No Open Checks. US Dollars please.
- Class conflicts may occur. Please schedule carefully. No refunds for missed classes. Refunds for classes will be given only in case of accident or illness to a terrier or owner, or for bitches in heat.
- Dogs must be leashed or crated at all times.
- No puppies under three months of age permitted on the trial grounds. This includes the camping area. Anyone violating trial rules will be excused from all classes and asked to leave the trial site; no refunds.
- No puppy sales are permitted on the trial site.
- Unsportsmanlike conduct will not be tolerated at any time during the trial, anyone demonstrating such will be dismissed from the grounds.
- Provide all certificates for those classes for which they are required.
- JRTCA rulebook can be downloaded at www.therealjackrussell.com A copy is also on site.
- A COPY OF JRTCA MEMBERSHIP CERTIFICATE MUST BE PRESENTED or mailed with entries.

Conformation will be under cover in the main arena with a limited number of 10x10 spots available. Priority will be given to those with the most terriers entered in conformation. You will receive a parking pass in your packet to place in your windshield.

#### **GENERAL RULES FOR EXHIBITORS**

#### RULES FOR EACH EVENT WILL BE POSTED AT THAT EVENT

- 1. All sanctioned classes are open to Jack Russell Terriers only.
- 2. Exhibitors and owners of terriers entered must be current JRTCA members and not be a member of a conflicting JRT organization or register their JRTs in any all-breed registry or conflicting JRT registry. If an exhibitor is found to be in violation of this policy, entry will be disqualified and no refunds will be given. If a violation is confirmed after the trial, placements will be voided from all JRTCA records. Exhibitors must submit a completed entry form including a signed waiver for every trial they enter.
- 3. Entries MUST be within the 10-15" JRTCA height standard for all sanctioned classes (with the exception of pups who have not yet met the 10" height standard); measuring devices will be available on the trial grounds.
- 4. Puppies (under 12 months) are not eligible for a championship in any division but their own. Puppies are eligible to compete only if they have reached their four-month birthday (not 16 weeks). A puppy's age is the actual age the pup is on the day of the trial.
- 5. Bitches in season may not compete in any division. Pre-entry fees of bitches in season will be refunded with a veterinarian certificate, or as otherwise agreed upon by the Trial Chairperson.
- 6. Spayed or neutered terriers may compete in Miscellaneous Conformation. They may not compete in Puppy, Family\*, Open or Working Conformation. \*Note: For Family Classes, Brood Bitches and Stud Dogs entered may not be spayed/neutered. The offspring at their sides may be intact or spayed/neutered.
- 7. A terrier bred by a sanctioned JRTCA Judge may not be shown under that Judge in the conformation division.
- 8. Terriers owned or co-owned by the Trial Chairperson, or any member of their household, may not be entered in any phase of the competition, with the exception of Child and Youth Handling.
- 9. Terriers owned by judges may not be entered in the division or section in which they are judging but may enter the competition in any other division. (Exception Ring 2 Nationals judge may have terriers shown in Ring 1)
- 10. Terriers owned by stewards may be entered in any division provided that they find a substitute to perform their duties or have someone else show their terriers.
- 11. Requests for the measurement of a terrier entered in any class number may be made only by another exhibitor in that same class number or by the Judge EXCEPT in Racing. Requests for the measurement of a terrier in Racing may be made by the Judge or by an exhibitor with a terrier entered in the same class number; OR, if classes are split by gender, may call for the measurement of a terrier of the opposite gender in the same age and height category. (Example: The owner of an under adult dog entered in Racing may call for the measurement of an under adult bitch as the potential exists for them to race each other in the Championship Races.) Exhibitors racing puppies may call for the measurement of a puppy in a different age category as long as it is in the same height category. The person making the request for measurement must name the terrier or terriers they wish to have measured, but requests for measurement of entire classes will not be honored. The measurement of the terrier will be considered the terrier's official height for the duration of the trial. Only JRTCA height cards issued after September 1999 will be
- 12. Excessive use of squeaky or fur-like baiting devices by exhibitors is prohibited in the Conformation ring and may result in the exhibitor being excused from the class. "Excessive use" will be at Judge's discretion.
- 13. Exhibitors participating in the JRTCA Working Terrier classes, or Certificate Go-To-Ground and Super Earth must submit the appropriate JRTCA certificates with pre-entries or at the time of post-entry. The Judge may require a copy of the certificate be presented to the Ring/Den steward at time of judging. Registered terriers may submit a copy of NHC application signed by a JRTCA Working Judge within 30 days of the date it was issued.
- 14. Puppies under the age of three months are not permitted on the trial grounds. Any person violating this rule will be excused from all classes entered and asked to leave the trial site. (This applies to RVs and Campers, if at the same address as the trial grounds).(01/22)
- 15. All dogs must be leashed or crated except when competition requires off-leash work. No liberty leashes allowed.
- 16. Overly aggressive dogs, or an owner's failure to control their dog, may result in disqualification at the discretion of the Judges or the Trial Chairperson.
- 17. The abuse or severe disciplining of dogs on the trial grounds is prohibited. Anyone displaying such behavior will be asked to leave the trial site, and no entry fees will be refunded.
- 18. Dogs other than JRTs on the grounds may be excluded or permitted at the discretion of the Trial Chairperson.
- 19. Exhibitors are responsible to double check the classes they have entered and be on time. No refunds will be given for missed classes.
- 20. The owner/handler of a terrier entering any class does so at his/her own risk and agrees to abide by the rules of the JRTCA and the trial. A copy of the JRTCA Rule Book can be downloaded from the JRTCA website (www.therealjackrussell.com).
- 21. Unsportsmanlike conduct, or the use of foul and abusive language, will not be tolerated. Anyone demonstrating such conduct will be asked to leave the trial site and no entry fees will be refunded. In addition, such conduct will be subject to penalties which may include the suspension of membership, restriction from entering the JRTCA National Trial, and/or fines. Trial Chairpersons have the right to refuse any entry at their discretion.
- 22. All dogs brought to the trial must be current on vaccinations. No dogs of any age may be brought to a trial who have suspicion of contagious or infectious disease.
- 23. Judges may not eat, smoke, vape, or use cell phones while judging their event. (01/22)
- 24. THE JUDGES' DECISIONS ARE FINAL IN ALL DIVISIONS.

#### **DIVISION A: RACING**

- All terriers including 4-6 month puppies, must be muzzled. Collars should be off.
- Basket Muzzles preferred. No colored muzzles only black, white, brown/tan, or clear muzzles will be acceptable. No open-ended muzzles. NO BASKERVILLE MUZZLES.
- All terriers entering the catch area during a race without a secured muzzle will be disqualified.
- ALL REQUESTS FOR HEIGHT MEASUREMENT MUST BE MADE BY 7:30 AM TO THE RACING JUDGE. Terriers will be measured with approved JRTCA wickets.
- Terriers MAY NOT cross-enter between Adult, Veteran & Senior classes.
- No Cell Phones or Smoking in the catch pen or by the start area, by anyone.
- Qualifications for Championship runoffs: Terrier must place first in a flat or hurdle race final to qualify for championship run offs. First to the hole is not necessarily first through the backside of the barrier. (01/22). A terrier MUST ENTER AND FINISH in both, at least one flat race AND one hurdle race at the beginning level based on trial entries (heat, semi, final). A terrier must continue to advance, if qualified, to all additional semi-final heats up to the final championship race. If injured, the terrier is then finished and cannot race in the final. A FINISHED race is when the terrier runs down the track unassisted (by owner or anyone else) with a secured muzzle to the backside of the barrier. In the event a terrier does not meet all the above criteria, the second place terrier in the final of that class (either flats or hurdles) will qualify for the championship run off if they meet the criteria as outlined above. (01/20)
- Other Terriers: Terriers, 6 months and older, not registerable or recordable with the JRTCA. May not cross-enter into any sanctioned racing classes.

#### **DIVISION B: YOUTH - NO ENTRY FEE**

- Child Handlers 5-9 years of age. They must handle a six month or older Jack Russell terrier.
- Youth Handlers: 10-16 years of age. The youth handler must handle the same adult terrier in all Youth Division classes entered. No puppies please. See rules for exceptions regarding injured terrier.
- Child/Youth exhibitor's age is determined as of January 1st of the current calendar year; except for those children turning 5 years of age. They may start competing in Child Handler any time of the year following their 5st birthday.
- · Child/Youth entries must be JRTCA members either under a family membership or under an individual Youth membership.
- Please list class number, child/youth's name, birthday, and dog's name on entry form.
- Quality of the dog is NOT to be considered.
- Points are: 1s=8 pts., 2s=6 pts., 3s=5 pts., 4s=4 pts., 5s=3 pts., 6s=2 pts., & Participation=1 pt.
- 47 Child Handler. Open to any child aged 5 through 9, handling a Jack Russell Terrier, six months of age or older. This class is offered as an introductory experience in handling and learning about the Jack Russell Terrier. Judged on child's ability to present his/her dog and beginning knowledge of the Jack Russell
- **Child G-T-G**. Open to any child aged 5 through 9, handling a Jack Russell Terrier, six months of age or older. Judged on the child's ability to present his/her dog and knowledge of Go-to-Ground. To be run through the 10-foot Novice liner; time not to be considered. (Non-Sanctioned)
- **49 CHILD HANDLER HIGH SCORE & RESERVE** Awarded to the highest scoring child and runner-up. Points earned in Child Handler & Child G-T-G each day. No entry fee. (non-sanctioned)
- **Youth Handler**. Open to any youth aged 10 through 16, handling an adult Jack Russell Terrier. Judged on the youth's ability to present his/her dog and knowledge of the Jack Russell Terrier.
- **Youth Working Judge's Choice.** Open to any youth handler aged 10-16. Judged on the youth's knowledge of hunting and the working terrier, and ability to answer questions presented by a JRTCA Working Judge; no terrier to accompany handler in class.
- **Youth G-T-G**. Open to any youth aged 10 through 16, handling an adult Jack Russell Terrier. Judged on the youth's ability to present his/her dog and knowledge of Go-to-Ground. To be run through the 10-foot Novice liner; time not to be considered.
- **YOUTH HANDLER HIGH SCORE & RESERVE** Awarded to the highest scoring youth and runner-up. Points earned in Youth Handler, Youth Working Judge's Choice & Youth G-T-G each day. No entry fee.

#### **DIVISION C: CONFORMATION**

- · Cross entering is not permitted within or between the Open and Working Sections.
- Exhibitors participating in the working Classes <u>must submit the</u> <u>appropriate JRTCA Paperwork with entries</u>. The judge may require a copy of the Natural Hunting Certificate (NHC) to be presented to the ring steward at the time of judging.
- Registered terriers may submit a copy of the NHC Application, signed by a JRTCA Working Judge, within 30 days of the date it was issued.
- · Spayed or neutered terriers may only compete in Miscellaneous Conformation classes.
- · Child Youth Conformation will start first.
